Signatory agrees to indemnify, defend, and hold The Rotary Club of Columbia Falls, its officers, agents, attorneys, employees and their respective successors and assigns harmless from and against any and all liability, claims, losses, damages, injuries or expenses (including reasonable attorneys' fees), arising out of signatories participation in the Night of Lights Parade on Nucleus Avenue in Columbia Falls, MT on December 7, 2018 or any negligence by signatory or violation by signatory of any local, State, or Federal law or regulation while participating in the aforementioned parade. In the event a claim should be brought or an action filed against the Rotary Club of Columbia Falls with respect to the subject of this Agreement, signatory agrees that the Rotary Club of Columbia Falls may, at its election, employ attorneys of its own selection to appear and defend the claim or action on behalf of the Rotary Club of Columbia Falls, at the expense of signatory. The Rotary Club of Columbia Falls, at its option, shall have the sole authority for the direction of the defense and shall be the sole judge of the acceptability of any compromise or settlement of any claims or actions against the Rotary Club of Columbia Falls.
